# Relative held for abetment in Indirapuram suicides-murders

**GHAZIABAD HORROR** Brother-in-law, named in purported suicide note, arrested day after crime; he has denied all charges

GHAZIABAD: A day after Gulshan Vasudeva and his family were found dead in an Indirapuram high-rise campus, police on Wednesday arrested his brotherin-law on charges of abetment to suicide. Rakesh Verma was arrested following an FIR lodged by Vasudeva's brother Devendra Vasudeva.

A suicide note found in the flat held Verma responsible too, said police

Verma, however, denied that he owed Vasudeva any money. According to police. Vasudeva had allegedly invested around ₹1 crore in Verma's business but failed to return the money that led to pushing Vasudeva into a financial crisis.

On Tuesday early morning, Vasudeva (45) and his wife Parveen (43), who together ran a garments business, had allegedly jumped from their eighth floor flat in Krishna Apra Sapphire apartments after killing their teenage children. Their employee Sanjana (26) had also jumped with them. She died in hospital.

According to police theory Vasudeva and his wife operated two businesses related to jeans and garments for children at Gandhi Nagar in Delhi and were facing financial crisis as a result of cheating allegedly committed by Verma in 2015.

"Verma lured Vasudeva to invest ₹1.09 crore property busi-

ness. Later. Vasudeva took money from his acquaintances and also close friend Praveen Bakshi and gave it to Verma. Verma paid back the money through several cheques, which bounced," said Sudhir Kumar Singh, senior superintendent of police(SSP).

"As a result of the financial issues, the family took the extreme step of taking their lives. Verma told us that he had not been in touch with Vasudeva for the last over one and half years. and not even on the day of the incident. He also told us that he returned about ₹98 lakh, but Vasudeva was asking for a total amount of ₹1.39 crore, which included 5% interest amount also," SSP added.

Vasudeva's friend Bakshi had got two FIRs lodged against Verma and his mother Phoola Verma in 2015 for criminal breach of trust and cheating at

mar Graden Extn Lin Ghaziabad Before ending their lives Vasudeva had also made a video call to his friend 70-vear-old Rakesh Arora, a resident of Jhilmil in East Delhi, and showed him his two dead children as well as the suicide note scribbled on the wall.

"These are money for our last rites... We five have a last wish that our bodies should be cremated together. The person responsible for our death is this... Rakesh Verma," the note scribble on the wall read

Verma denied all charges. "I had no communication with him on any matter ever since. I am saddened by the incident, especially the death of the two children. I have paid back all his money and whatever is to be told will be told before the court," he

## No money allocated for bus camera project from Nirbhaya fund: Gahlot

**NEW DELHI:** Transport minister Kailash Gahlot on Wednesday said the Delhi government will fund CCTV cameras, panic buttons and other safety devices in city buses as the Centre has

"failed" to disburse money from

The issue was raised at a time when questions are being raised over the utilisation of the money from the fund in the aftermath of the brutal murder and rape of a veterinarian in Hyderabad. In 2016, the Central and the Delhi governments had stated that the Union Ministry of Women and Child Development (MWCD) had approved Rs 140 crore from Nirbhava funds for installation of CCTV cameras and GPS devices

'Three years have passed and till date we have not received a single penny for the project. This is despite the empowered committee under the fund approving

With no response from the Centre, the Delhi government has now decided to fund the project on its own.

A cabinet meeting is likely to be held on Thursday to discuss this proposal and pass it. The cost of the project has been estimated at Rs 149 crore

As per the proposal prepared by the transport department on Wednesday, the scope of the

project includes installing three CCTV cameras, two sirens, a dedicated automatic vehicle location system and panic buttons in at least 5.000 DTC and cluster buses.

The minister said a central control and command centre will be built at the Kashmere Gate inter-state bus terminal (ISBT). Mini control rooms will also be set up in all DTC and cluster bus depots.

"On pressing a panic button sirens installed in these buses will go off. The first response of panic buttons will go to the concerned depot and the central control room. At the depot level, an internet based two-way communication system will be used to talk to the driver immediately to ascertain the nature of emergency," Gahlot said.

After ascertaining the nature of emergency, the required response will be decided. Also, hotlines will be created from the central control room with Delhi Police, Delhi Fire Service and ambulances for direct action.

### CP's Sufi secret

#### A secretive serene spot tucked in the city's heart

One has seen the whole of Connaught Place (CP), isn't it? It's one beloved destination in the capital familiar to almost every Delhiite. Each of us has our own favourite cafe, cinema showroom or bakery. Indeed, these CP landmarks are part of our biographies involving romances, break-ups, friendships

But one of CP's best kept secrets is a sprawling Sufi shrine. Half the pleasure of enjoying it is to search for the

The shrine is tucked away in the Outer Circle, just across the road from a hotel, which, originally known as Marina, was one of New Delhi's

earliest hotels. On reaching the spot you have to look hard for a narrow lane speckled with painted signboards advertising a number of oddities, including an astrologer's services. The smallest of these banners, the one you are most likely to miss, says: Dargah-e-Aliya

The almost-invisible passageway snakes up into the shrine. A totally different world exists in this marbled courtyard—so tranguil



that you feel as if peacefulness is dropping straight from the sky. Rows of graves lie under rows of leafy neem trees.

The dargah is devoted to Shah Abdul Salaam Faridi Chishti, a descendant of Sufi saint Salim Chishti of Fatehpur Sikri. A gentleman perched on the shrine's dry fountain says that the shrine originally encompassed 60 bighas. This area used to be called Baanskoli, a village that was eventually replaced by Connaught Place, he informs.

The patron saint's grave is snuggled inside a vaulted chamber. The afternoon sunshine is falling softly, turning the stony surface into a pile of gold. This sprawling compound feels remote. In the city's heart, this island of astonishing serenity has survived the centuries even as the world it came from has long


NEWDELHI: Following a "successful" experiment to decongest

key stretches, the Delhi Traffic Police said now only one-way traffic will be allowed on three roads —Abai Marg from San Martin Marg to Sardar Patel Marg, Kushak Road from Teen Murti to Rajaji Marg, and Purana Qila Road from C-Hexagon (India Gate roundabout) to Mathura Road —during evening peak rush hour, officials said.

Joint commissioner of police (traffic) Meenu Choudhary on Wednesday said the department has signed a memorandum of understanding with global research organisation World Resources Institute, India, to improve road safety and decongest stretches with high traffic volume

As a pilot project, the three stretches, were made one-way from 5pm to 8pm. "This was done as an experiment but we have noticed promising results. The one-way scheme has been notified and it has helped us manage traffic better on these stretches," said Choudhary.

According to the plan, no traffic movement will be allowed from Sardar Patel Marg towards San Martin Marg. On Kushak



Road traffic will not be allowed  $to\,ply\,from\,Rajaji\,Marg\,towards$ Teen Murti Marg and movement will also be closed on the Purana Qila Road from Mathura Road towards the India evenings.

Gate roundabout. The plan will be in place from 5pm and 8pm. Senior officials said that it was noted that the waiting time on these stretches was reduced by nearly 10 minutes during peak traffic hours

These three stretches are an important link in central Delhi, which connects west Delhi and south Delhi with the Lutvens' zone. Sardar Patel Marg is also among the busiest roads in central Delhi, which according to traffic police estimates gets nearly 50,000 to 80,000 vehicles during the peak traffic rush of

Amit Bhatt, director of integrated transport at WRI, which is providing technical support to the traffic police for the implementation of the plan, said nearly 18 stretches across the city was suggested by the traffic department and were examined independently for road safety. pedestrian infrastructure and waiting time. Traffic load from

"The traffic police, through locally collected data, had sug gested these stretches, for an alternative traffic arrangement that could decongest the roads without compromising on the technicalities. We reviewed the stretches and provided a plan that has been implemented, Bhatt said.

He said the idea behind the evaluation of the one-way arrangement was that despite the change in traffic movement it remains inclusive for all including cyclists and pedestri

#### Cannabis worth ₹1 crore seized

NEW DELHI: The Delhi Police said they have busted two gangs of drug peddlers and seized nearly 300 kilograms of cannabis (ganja), which they said was worth around R1 crore, from four men arrested by teams of crime branch and Dwarka district police between Monday and

Tuesday. The arrested men included the 20-year-old son of a druglord, Bijay Kumar Rai, who has been operating an interstate drug ped $dling\,gang\,from\,Bihar, the\,police$ said on Wednesday.

The arrested men were identified as Rai's son Sonu Kumar and his associate, Suresh Kumar, 22. The two were arrested with 19 kilograms of cannabis by the Dwarka police

Those arrested with 280 kilograms of cannabis by the crime branch were Sonelal alias Sonu. 28, and Raju Pandit, 30

In the first operation, the crime branch team on Tuesday received information regarding the delivery of a consignment of drugs near the Ghazipur paper market. Accordingly, a trap was laid and the police caught two men with a truck with 280 kilograms of cannabis, hidden in seven plastic drums.
